# 3. COMPOSITION/INFORMATION ON INGREDIENTS

Being a sand based product there is a risk that the 'Respirable Crystalline Quartz' (RCQ) content may be hazardous to human health. While the product is wet and being applied the amount of airborne RCQ will be reduced but it is strongly advised that suitable respiratory protection (see exposure controls) is worn to minimise the possibility of inhalation. Once dry, any residues, grinding or strong abrasive forces on the finished product may reintroduce RCQ into the air so caution should be taken.

### HANDLING AND STORAGE

## 11. TOXICOLOGICAL INFORMATION

**Mutagenicity** Insufficient data available for this product to classify as a mutagen.

Carcinogenicity Dried Sand is not classified as a carcinogen by NOHSC. Crystalline silica is classified as

carcinogenic to humans (IARC Group 1), however due to low levels present and product

application, the criteria for classification is not met.
